LARRY WEISS MEMORIAL SCHOLARSHIP PROGRAM RULES

- 1. The Allied Building Metal Industries, Inc., Larry Weiss Memorial Scholarship Program is open to all graduating high school seniors and high school graduates who are either full-time employees, or sons or daughters of full-time employees, of a member firm of Allied Building Metal Industries, Inc., or of a contributing employer to the industry's advancement funds. Included as eligible applicants are such full-time employees who are members in good standing, and children of such members in good standing, of Structural Iron Workers Local Unions Nos. 40 and 361, or of Ornamental Iron Workers Local Union No. 580. No owner, or children of owners, of Allied members or of contributing employers are eligible nor are any paid officers or agents of the above labor organizations or their children. Notwithstanding the foregoing, an individual that owns, solely as a passive investor, two and one-half percent (2.5%) or less of the outstanding securities or shares of any company that is an Allied member or contributing employer to the industry's advancement funds shall not, by itself, be considered as an "owner" of the company for purposes of this section 1. As set forth below, in certain limited instances, applications will be accepted from students already enrolled in college or other educational institutions.
- 2. Scholarships will be awarded to those attending, or planning to attend, on a full-time basis, any accredited college, university, junior college, technical, or trade school located in the United States. Please note preference will be given to applicants pursuing a degree in architecture, engineering, or any other vocation directly related to the construction industry.
- 3. Scholarship awards are competitive and will be based on, among other relevant factors:
 - Academic standing of the student;
 - Recent college entrance examination (SAT, ACT) scores;
 - · Extracurricular activities and leadership;
 - Character references;
 - Type of program being pursued; and
 - Any other information deemed pertinent by the Selection Committee.
- 4. Candidates must be willing to accept the decision of the Selection Committee as final and binding. The Selection Committee reserves the right to interpret all rules and regulations regarding the Scholarship Program; decisions by the Committee are final and irrevocable.
- 5. A total of six (6) initial scholarships will be awarded each year. Each of the six (6) initial scholarships will be awarded in the amount of twenty-five (25%) percent of the school's tuition charges up to a maximum of Three Thousand (\$3,000.00) Dollars per year. Interested candidates must submit their applications for the initial scholarship award to Allied's office by no later than **August 1**. Thus, for academic year 2024-2025, for instance, applications for the initial scholarship award would be due no later than August 1, 2024.

- 7. Initial scholarships may be <u>renewed</u> for up to four (4) years. In order to renew the initial scholarship, the initial scholarship award recipient must maintain satisfactory progress toward completion of his or her program of study. In this regard, initial scholarship award recipients must maintain at least a "C" grade point average to be considered for scholarship renewal. Eligible initial scholarship recipients must submit their applications for scholarship renewal to the Allied office by no later than <u>August 1</u>. Thus, for academic year 2024-2025, for example, scholarship renewal applications would be due no later than August 1, 2024. Scholarship renewal applications also must be accompanied by an official school transcript.
- 8. The Selection Committee retains the right to revise, change or cancel the Scholarship Awards Program at any time without prior notice.
